V. Written Information Items

1. Transportation Demand Management and Mobility Plan Update Peter Bilton, Central Staff

The NJTPA, with consultant support from ICF, is developing a transportation demand management (TDM) and mobility plan for the NJTPA region. TDM is a set of strategies to improve the efficiency of the transportation system, including encouraging the shift from single-occupant vehicle trips to transit or shared vehicles, or to trips out of peak periods. A draft list of 51 TDM and mobility strategies was refined via a Technical Advisory Committee (TAC) survey and discussion at a September 30 TAC meeting and documented in a technical memorandum. Six of these strategies were selected for more detailed development into implementation briefs that will detail potential partner agency and stakeholder roles, action steps, timelines, and resource needs. Outlines of these briefs will be presented to the TAC for discussion in December.

2. Complete Streets Technical Assistance Update Peter Bilton and Keith Hamas, Central Staff

Under Complete Streets Technical Assistance – Phase 2, the Voorhees Transportation Center at Rutgers and the Sustainability Institute at the College of New Jersey are providing training and planning-level technical assistance to municipalities on bicycle networks, walkable community workshops, conceptual renderings for complete streets, and conducting Crime Prevention Thought Environmental Design audits. Workshops and virtual public meetings have been completed for Bradley Beach, Cranbury, Dunellen, Franklin Township, Garwood, Hackensack, Manville, and West Orange projects. The consultant team is preparing final reports that will be reviewed by NJTPA, municipal leaders, and state and subregional stakeholders.

> Meeting Minutes October 13, 2020

I. Roll call

RTAC Chair Mark Jehnke called the meeting to order at 10:30 a.m. Beverly Morris, Central Staff, called the roll and 17 voting members were present for the virtual meeting via GoToMeeting.

II. Approval of Minutes

A motion to approve the minutes of the August 10 meeting was made by Hunterdon County, seconded by Essex County and carried with 15 affirmative votes. City of Newark and Passaic County abstained.

III. Presentation: Active Transportation Background Paper for Plan 2050

Aimee Jefferson, Central Staff, said the paper is the first in a series of white papers that will inform the long range transportation plan update. She said the paper provides a "snapshot" of existing active transportation conditions, which can include walking, biking, scooter use, and skateboarding. She said the paper also discusses the health and economic benefits of active transportation and how to incorporate it into planning work. She noted the limited availability of data on active transportation modes and sidewalk and trail networks

Keith Hamas, Central Staff, said the paper also outlines a combination of strategies and programs employed by the NJTPA and its planning partners to address the principal guiding goal of planning for active transportation – connectivity. He noted some of the programs related to active transportation, including the Local Safety Program, Transportation Management Association (TMA) programs, Planning for Emerging Centers, the Complete Streets Technical Assistance program, the Together North Jersey Technical Assistance program, as well as coordination with the New Jersey Department of Transportation (NJDOT) on the State Strategic Highway Safety Plan, Congestion Mitigation and Air Quality (CMAQ) initiatives such as the Transportation Clean Air Measures program, Safe Routes to School, and other opportunities.

Ms. Jefferson followed with some case studies that demonstrate how different initiatives and programs can align at the local level. IV. Information Items

1. TMA Report

Tara Shepherd, goHunterdon, said the TMAs had submitted their FY 2022 work programs to the NJTPA. The programs include core work in the areas of accessibility, economic development, reliability, environmental and safety programming and supplemental programming related to Street Smart NJ campaigns and Coordinated Human Services Transportation Plan initiatives. She said October is Pedestrian Safety Month and the TMAs are engaged with pedestrian safety education and encouragement activities.

2. Plan 2050: Transportation, People and Opportunity Update

Lois Goldman, Central Staff, said NJTPA staff members are working with a financial element consultant and will hold meetings with partner agencies and Metropolitan Planning Organizations soon to discussion financial assumptions for the long range transportation plan update.

Ted Ritter, Central Staff, said the <u>Plan 2050 website</u> includes a survey in multiple languages. He encouraged all to take the <u>survey</u> and share it through county and municipal communication channels, social media, and email. Mr. Ritter reported that, with consultant support, NJTPA staff conducted five virtual public workshops, one entirely in Spanish. He said the public outreach team is exploring ways to attract a larger and more varied audience for upcoming virtual workshops. Mr. Ritter said the first symposium in the TPA Tuesdays series was held October 6 and focused on Adapting to Change.

3. FY 2022 Unified Planning Work Program (UPWP) Development Update

Karen Rosenberger, Central Staff, updated the Committee on the development of the FY 2022 UPWP. Prior to the meeting Ms. Rosenberger distributed a package of the following materials to Board and RTAC members via email: FY 2022 UPWP Development Schedule for Chapters I, II, III and IV; a letter outlining NJDOT Planning Priorities for MPOs; a letter outlining FHWA priorities for MPOs; and a slide presentation outlining elements of the FY 2022 UPWP.

Ms. Rosenberger said input from the Trustees and RTAC members will be sought throughout the development process, and she asked that any suggestions for the program update be submitted by October 31, so they may be incorporated into the first draft, which will be distributed for review in December. Ms. Rosenberger said subsequent comments on the draft program are requested by

January 7. The final draft will be presented to the standing committees for endorsement in February 2021 and to the Board for approval in March.

4. FY 2022 Subregional Transportation Program Solicitation

Peter Zambito, Central Staff, thanked RTAC members who reviewed the draft program solicitation and provided helpful feedback. He said several changes were made in response to the feedback, including additional detail or examples of successful projects, changes to the slate of core and elective activities, participation on RTAC in a leadership capacity and participation in environmental education efforts. Mr. Bilton said proposals are due October 30.

5. NJTPA CMAQ Performance Plan and NJDOT Mid Period Performance Measures Reports.

Rick Cippoletti and Keith Miller, Central Staff, said that NJDOT has submitted the NJTPA CMAQ Performance Plan to the Federal Highway Administration FHWA as part of its Mid Performance Period Progress Report. This Plan demonstrates the region's progress on three federally required performance measures, two dealing with congestion and one concerning the reduction of vehicle emissions. The NJTPA's plan shows that targets for these three measures have been met, and it also provides a list of upcoming CMAQ projects and discusses their part in improving air quality. 6. Together North Jersey (TNJ) Initiative Update

Jeff Perlman, Central Staff, said TNJ members and the NJTPA are collaborating with the Voorhees Transportation Center (VTC) to update the TNJ plan. As part of the process, the four TNJ task forces (Efficient, Competitive, Resilient, and Livable) are holding meetings in October and updating strategies through early 2021. Also, the VTC is developing a survey to inform the updated plan on county level issues. Mr. Perlman said the TNJ Initiative will collaborate with New Jersey Institute of Technology to conduct three one-hour webinars on brownfields redevelopment on October 26, November 5 and November 12. He noted that the Resilient Task Force will be scheduling a webinar on using its web-based Best Practices Sustainability Toolkit.
