VI. Written Information Items

1. Subregional Studies Program Update Blythe Eaman, Central Staff

Central staff issued the FY 2022 – FY 2023 Subregional Studies Program (SSP) Solicitation on June 5. The SSP is a competitive grant program that provides funding for subregions to conduct local studies that address regional needs, and that support implementation of the NJTPA's Plan 2045 or preparation for the next Long Range Transportation Plan. Studies are conducted over a two-year period and are solicited annually. Past studies have included bicycle and pedestrian plans, corridor studies, and safety plans. These studies are included in Chapter II of the UPWP.

Central staff welcomes phone conferences with subregions to discuss ideas for a study during the month of June. Thumbnail Sketch Proposals are due on July 6. Once central staff has reviewed the Thumbnail Sketch Proposals, staff will notify subregions of eligibility to submit a full proposal by mid-July. Full proposals will be due September 4, 2020 and applicant interviews will take place in later in September.

2. Congestion Management Process Update, Objectives and Performance Measures Eugene McGuinness – Central Staff

Incorporating input from the Congestion Management Process (CMP) Working Group (with representation from subregions, state partners and neighboring MPOs), a technical memorandum was produced to identify CMP Objectives and Performance Measures. These will be used to assess transportation needs throughout the region and highlight related strategies and objectives. The objectives include:

- improving accessibility to destinations;
- ensuring equitable access for all;
- enhancing the reliability of travel for all modes;

- ensuring that alternatives to driving alone are supported;
- enhancing the usability of public transit;
- increasing the viability of walking, bicycling, and micromobility options;
- optimizing freight movement sensitive to local context; and
- addressing bottlenecks and existing delay while optimizing existing roadway capacity.

Using performance measures to identify needs helps to uncover the functioning and effectiveness of transportation in the region. Some examples are: transit frequency; non-single-occupant vehicle mode share; travel time reliability; and average travel time. Development of the needs assessment is currently underway, drawing upon collected data and workshop feedback. It will be the focus of the next CMP Working Group meeting, slated for early summer.

3. CMAQ Solicitation Update

Liz DeRuchie and Peter Bilton - Central Staff

Last month, the NJTPA solicited applications for the Transportation Clean Air Measures (TCAM) and Local Mobility Initiatives programs, which are funded through the federal Congestion Mitigation and Air Quality (CMAQ) program. Nine Local Mobility Initiative and 16 TCAM thumbnail sketch proposals were received by the May 6 deadline. Thumbnail submissions were screened for eligibility and feasibility, and selected applicants were invited to submit full proposals. The purpose of these competitive programs is to advance readily implementable and innovative projects and services that improve air quality and reduce congestion in the NJTPA's air quality maintenance and non-attainment areas.

4. Complete Streets Technical Assistance

Peter Bilton and Keith Hamas, Central Staff

Under Complete Streets Technical Assistance – Phase 2, the Voorhees Transportation Center at Rutgers and the Sustainability Institute at the College of New Jersey are providing training and planning-level technical assistance to municipalities on how to implement Complete Streets. Within each of the following eight community projects, the goal is to enhance safe connectivity for bicycles and pedestrians to key destinations including parks, schools, transit, and commercial centers. Bradley Beach, Dunellen, Hackensack, Manville, and West Orange were selected for Walkable Community Workshops, Cranbury and Garwood will receive a Bicycle Corridor or Network Plan, and Franklin Township will receive a Crime Prevention Through Environmental Design workshop. In addition, a brief public education video is being created to explain and promote Complete Streets. The video will be available for community meetings, websites, and social media.

In April and May, virtual kick-off meetings were completed with the recipients and work plans were finalized for each site. In lieu of in-person site visits, walk-throughs were conducted during the kick-off meetings using Google Street View. The project team is currently completing existing conditions summary reports of traffic, crash, development and crime information and developing public workshop presentations. Public workshop formats have been adapted for a virtual environment due to COVID-19 and will be conducted primarily via WebEx.

The first public workshop is scheduled for Manville on June 9 at 3:30-5:30 p.m., with the remaining workshops to be scheduled in June and July. In addition, at the request of Dunellen, the team prepared an initial complete streets assessment of Madison Ave., which is scheduled for repaving prior to conclusion of the project. The project is planned to be completed in the fall of 2020 with final reports and presentations for each town.

5. Together North Jersey (TNJ) Initiative

Jeff Perlman, Central Staff

NJTPA staff worked with the Voorhees Transportation Center (TVC) to schedule and hold TNJ Task Force meetings in May. The Competitive, Efficient, Livable and Resilient Task Forces convened virtual meetings to begin discussing the anticipated re-examination of the strategies and actions in the current TNJ plan as well as other activities such as future Training Institute Workshops.

NJTPA Staff continued working with VTC to advance Local Technical Assistance projects to the City of Hackensack and the Borough of Bound Brook.

For the Bound Brook Visual Identity and Wayfinding Project,, the TNJ team conducted virtual public outreach in April and developed multiple design options for wayfinding themes, which was presented to the Borough for feedback on May 27. The team will finalize the wayfinding theme and conceptual designs in June.

For the Hackensack Demarest Place Art Walk project, the TNJ team concluded stakeholder and public outreach through a virtual outreach meeting with the Hackensack Creative Arts Team on April 22. During this meeting, the team presented conceptual drawings and findings from outreach and gathered input from participants about how to incorporate art into activating the Demarest Place site. The TNJ team will develop and finalize concept drawings and a summary of the public engagement in June.

> Joint Meeting Minutes April 20, 2020

I. Roll Call of Members

The meeting was held online via GoToMeeting. Freeholder John Bartlett, Passaic County, called the meeting to order at 10:30 a.m. Beverly Morris, Central Staff, called the roll. There were 14 voting members of the Project Prioritization Committee and 13 members of the Planning and Economic Development Committee present.

NJTPA Chair Freeholder Kathy DeFillippo, Morris County, said she appreciated the support of all the Trustees who were able to participate in the meeting even while dealing with the ramifications of COVID19 and other issues in their subregions.

I. Approval of Minutes

Morris County moved to approve the minutes of the February 18, 2020 meeting, and Union County seconded the motion, which was approved by voice vote. Essex County abstained.

II. Regional Transportation Advisory Committee (RTAC) Update – Mark Jehnke, Ocean County

RTAC Chair Mark Jehnke, Ocean County, reported on the activities of the April 13 RTAC meeting. He said Central Staff led a discussion on how COVID19 was affecting planning in the region and development of the 2050 long range transportation plan. Mr. Jehnke said staff also provided information items, including the upcoming Tech Tools for Planning Expo, the Subregional Studies Program, the CMAQ solicitation and the Complete Streets Technical Assistance Program. The committee also had a chance to review the action items on the agenda for this Joint Committee meeting.

Freeholder Bartlett thanked Mr. Jehnke and the RTAC members for seeing that work continues in spite of the difficult circumstances.

III. PPC Action Items

1. Minor Amendment to the FY 2020 – 2023 Transportation Improvement Program (TIP) to Add the Downtown Toms River Loop Road Project in Ocean County,

Eve Chamberlain said this project received a federal Better Utilizing Investments in Leverage Development (BUILD) grant of \$5.66 million for Fiscal Year 2020 and must be added to the TIP. The project will undergo a Concept Development study.

A motion to endorse the resolution was made by Union County, seconded by Warren County and carried unanimously.

2. Minor Amendment to the FY 2020 – 2023 Transportation Improvement Program to Add the Laurel Avenue, NJ TRANSIT North Jersey Coast Line Bridge Project in Monmouth County

Ms. Chamberlain said this project will be ready for Concept Development in Spring 2020 and needs to be amended into the TIP. She said that, according to NJDOT, \$800,000 in FY 2020 Surface Transportation Block Grant Program–FLEX funds are available for this purpose.

A motion to endorse the resolution was made by Monmouth County, seconded by Union County and carried unanimously.

3. Minor Amendment to the FY 2020 – 2023 Transportation Improvement Program to Add Federal Funds to the Rumson Road Over the Shrewsbury River (CR 520) Project in Monmouth County

Ms. Chamberlain said a revised cost estimate shows the need for increased construction funding. This amendment would add \$10.9 million in FY 2020 Surface Transportation Block Grant Program (STBGP) funding and an additional \$20.1 million in FY 2021. Ms. Chamberlain said the STBGP funds are available in the NJTPA Future Projects line item (DB# N063).

A motion to endorse the resolution was made by Monmouth County, seconded by Morris County and carried unanimously.

4. Minor Amendment to the FY 2020 – 2023 Transportation Improvement Program to Add the Riverbank Park Bike Trail Project as Requested by the Town of Kearny

Ms. Chamberlain said this project has completed the Design phase and needs to be added to the TIP to be advanced for construction. She said \$1.82 million in FY 2020 funds has been made available by the NJTPA through a funding agreement with the State of New Jersey.

A motion to endorse the resolution was made by Hudson County, seconded by Monmouth County and carried unanimously.

V. Information Items

1. Trans-Hudson Update

Dave Behrend, Central Staff, said stay-at-home orders have caused a drastic reduction in travel throughout the region, and trans-Hudson vehicular traffic had dropped by one third but is growing. He said the Port Authority of New York & New Jersey had gone completely cashless, collecting all tolls through EZ Pass or by mail. Transit ridership fell by more than 80 percent. Mr. Behrend said there has be no significant development in funding activity for the Portal Bridge and Hudson River Tunnel projects. He noted that, prior to the pandemic, the Secretary of Transportation spoke of increased focus on repairs to the existing tunnel and less emphasis on the replacement project.

2. Federal Policy Update

Mr. Behrend said the CARES act, the third COVID19-related bill, included approximately \$1.75 billion for NJ TRANSIT to help offset loss of revenue and other costs. He said the states are asking for federal aid for other transportation projects, largely due to the lost motor fuel tax revenue; the American Association of State Highway and Transportation Officials (AASHTO) has requested \$50 billion for states, and the National Conference of State Legislators echoed that request.

Mr. Behrend said there has been discussion about the need for greater investment in nationwide broadband coverage, especially if the level of telecommuting remains high. He said the Senate Environment and Public Works Committee had passed a highway infrastructure bill, and incorporating it, as-is, into a recovery bill has been suggested.

There is also discussion of Congress reauthorizing the FAST Act now to secure a federal funding commitment for transportation. The law will expire September 30, 2020.

Minutes

May 12, 2020

I. Roll Call

Project Prioritization Committee Chair, Freeholder John Bartlett, Passaic County, called the meeting to order at 2:00 p.m. Thirteen voting members were present for the online meeting.

II. Action Item:

Modification to the FY 2020 - 2023 Transportation Improvement Program (TIP) to Add Federal Funds to the Route 78 Rockfall Mitigation, Bethlehem Township Project as Requested by the New Jersey Department of Transportation

Eve Chamberlain, Central Staff, said the project is ready for authorization and requires additional federal funding in the amounts of \$6.994 million for Fiscal Year 2020 and \$1 million for 2022. She said the increase is due to updated costs for mobilization, excavation, environmental vibration monitoring and construction engineering. The funds are available from the Rockfall Mitigation line item in the TIP.

During the ensuing Q&A, it was noted that this is the second funding increase in a year for the project, which has had its initial estimated cost of \$30 million increased 50 percent to nearly \$46 million. Warren County Freeholder Jason Sarnoski, the Committee Vice Chair, noted that the cost of the project appears to be large in relation to the small size of the construction area. It was agreed that, while public safety is a priority, more information and discussion is needed between the NJTPA and NJDOT to gain a better understanding of the cost/benefit analysis supporting rockfall projects.

NJTPA Executive Director Mary Ameen pointed out that while the action had been referred to as a change order, it is not a change order in the normal sense of the term. She explained that the action adds money into the construction phase of a project whose cost previously was only estimated as part of the line item in NJDOT's rockfall program. Jim Vari, NJDOT, confirmed that once the project is advertised and bids are submitted, the actual costs versus the consultant-

based estimates become apparent. He noted that the cost estimates of some rockfall projects can be high compared to other types of projects.

It was also noted that concurrence from Hunterdon County was requested, and no objection to the project was raised.

A motion to approve the resolution was made by Morris County, seconded by Middlesex County and carried with 12 affirmative votes. Warren County voted "no."

III. Adjournment

At 10:54 a.m. a motion to adjourn was made by Warren County, seconded by Morris County and carried unanimously.

Summary of Action

Modifications to the FY 2020 - 2023 Transportation Improvement Program to Add Federal Funds to the Route 80, Riverview Drive (CR 640) to Polifly Road (CR 55) Project as Requested by the New Jersey Department of Transportation

<u>Action:</u> In order to advance the following project, the New Jersey Department of Transportation (NJDOT) has requested revising the FY 2020 – 2023 TIP to update programmed funding as detailed below.

Background: According to the *TIP Memorandum of Understanding*, when federal funds at a specified threshold are added to a project or program line, the request requires action by the NJTPA Project Prioritization Committee, with no further action required by the Board of Trustees. The requested revision detailed below is within that threshold.

Funding Revisions:

• Route 80, Riverview Drive (CR 640) to Polifly Road (CR 55), *Passaic County and Bergen County* DB# 11415

Based on recently updated schedule and cost estimates, this request is to advance Design funds from Federal Fiscal Year (FFY) 2023 into FFY 2022 and add \$7.759 million NHPP funds. Additionally, the title of the project needs to have a spelling error corrected (Polifly is the correct name of the road). (NHPP funds for DES in FFY2022 totals \$36 M) Funds are available from unobligated prior year funds.

Justification for Action: Approval of this revision to the FY 2020 - 2023 TIP will allow the funds to be secured and the referenced project to advance.

<u>Staff Recommendation</u>: Central Staff recommends approval of these actions.

<u>Action</u>: In order to advance the following project, the New Jersey Department of Transportation (NJDOT) has requested revising the FY 2020 - 2023 TIP to update programmed funding as detailed below.

Background: According to the *Memorandum of Understanding between the NJTPA, NJDOT and NJ TRANSIT*, when federal funds at a specified threshold are added to a project or when the addition of a phase of work delays the construction phase, the request requires action by the NJTPA Project Prioritization Committee. The following requested action is within that class. If the Committee approves this modification, no further action will be required by the Board of Trustees. Revision request details are outlined below.

Funding Revisions:

• Route 46, Main Street/Woodstone Road (CR 644) to Route 287, ITS, *Morris County* DB# 06366A Based on recently updated schedule and cost estimates, a Right of Way phase must be added and the construction phase of work must be reprogrammed into Federal Fiscal
