V. Written Items

1. Complete Streets Technical Assistance

Peter Bilton and Keith Hamas, Central Staff

Under Complete Streets Technical Assistance – Phase 2, the Voorhees Transportation Center at Rutgers and the Sustainability Institute at the College of New Jersey are providing training and planning-level technical assistance to municipalities on how to implement Complete Streets. Within each of the following eight community projects, the goal is to enhance safe connectivity for bicycles and pedestrians to key destinations including parks, schools, transit, and commercial centers. Bradley Beach, Dunellen, Hackensack, Manville, and West Orange were selected for Walkable Community Workshops, Cranbury and Garwood will receive a Bicycle Corridor or Network Plan, and Franklin Township will receive a Crime Prevention Through Environmental Design workshop. In addition, a brief public education video is being created to explain and promote Complete Streets. The video will be available for community meetings, websites, and social media.

In April and May, virtual kick-off meetings were completed with the recipients and work plans were finalized for each site. In lieu of in-person site visits, walk-throughs were conducted during the kick-off meetings using Google Street View. The project team is currently completing existing conditions summary reports of traffic, crash, development and crime information and developing public workshop presentations. Public workshop formats have been adapted for a virtual environment due to COVID-19 and will be conducted primarily via WebEx.

The first public workshop is scheduled for Manville on June 9 at 3:30-5:30 p.m., with the remaining workshops to be scheduled in June and July. In addition, at the request of Dunellen, the team prepared an initial complete streets assessment of Madison Ave., which is scheduled for repaving prior to conclusion of the project. The project is planned to be completed in the fall of 2020 with final reports and presentations for each town.

2. CMAQ Solicitation Update

Last month, the NJTPA solicited applications for the Transportation Clean Air Measures (TCAM) and Local Mobility Initiatives programs, which are funded through the federal Congestion Mitigation and Air Quality (CMAQ) program. Nine Local Mobility Initiative and 16 TCAM thumbnail sketch proposals were received by the May 6 deadline. Thumbnail submissions were screened for eligibility and feasibility, and selected applicants were invited to submit full proposals. The purpose of these competitive programs is to advance readily implementable and innovative projects and services that improve air quality and reduce congestion in the NJTPA's air quality maintenance and non-attainment areas.

Meeting Minutes April 13, 2020

Mark Jehnke

I. Roll call

Beverly Morris called the roll and 17 voting members were present. One more arrived after approval of minutes

II. Approval of Minutes

A motion to approve the minutes of the February 10, 2020 meeting was made by Sussex County, seconded by Hunterdon County and carried with 16 affirmative votes. Middlesex County abstained.

III. Discussion: Impacts of COVID-19 Pandemic

Immediate Impacts on NJTPA Subregional Work Programs - Angel Young, Central Staff, said the NJTPA understands that the subregional partners are adapting to a new work environment in response to the COVID19 pandemic, and that it may be challenging for some to submit and meet the current established deadlines for reporting on expenditures and task activities for the third quarter period ended March 31, 2020. She advised them to contact Central Staff if they foresee any issues with meeting their programmatic requirements and completing final products and deliverables. Ms. Young said that quarterly reporting reminder emails were sent to the subregions on April 1 and they included guidance for reporting under the special circumstances.

<u>Long Term Plan 2050 Considerations</u> - Lois Goldman, Central Staff, led a wide-ranging discussion on the potential impacts the COVID19 pandemic on future transportation planning work for the region and how this will be reflected in the long-range transportation plan update. Committee members discussed a variety of issues, including economic recovery, downtown and retail development, air quality, climate change, employment, equity, teleworking, transportation funding, commercial office market, and technology.

IV. Information Items

1. TMA Report

Tara Shepherd, goHunterdon, said in response to the COVID19 public health emergency, the TMAs activated their business continuity plans and moved to remote operations in March. To stay in communication with all stakeholders, including schools, employers and municipalities, the TMAs updated their websites to inform stakeholders of the status of remote operations and to share contact information. Ms. Shepherd said they are also leveraging social media platforms extensively. She said several TMAs are involved in direct response activities, and she noted that, while shuttles and on demand ride services are reduced or suspended, transport for dialysis patients continue.

2. CMP Working Group

Eugene McGuinness, Central Staff, said the NJTPA held its second meeting of the Congestion Management Process (CMP) Working Group in March online via GoToMeeting. The meeting was supported by the consultants, ICF and AECOM, and included representation from subregions, state partners, and neighboring MPOs. The group discussed technical materials and reviewed draft CMP objectives. Participants also discussed the use of performance measures relating to accessibility to destinations; alternatives to driving alone; public transit usability; freight; walking and bicycling; and travel time reliability. Mr. McGuinness said the objectives and performance measures will be used to guide the upcoming needs assessment phase of the study. The next working group meeting is slated for June.

3. PRIME Update

Jeffrey Vernick, Central Staff, said 29 planning studies and policies have been entered into the PRIME system consisting of 19 studies, 10 brief summaries and about 400 recommendations. He said the system is beginning to be used to retrieve and apply information. In terms of uses, Mr. Vernick said staff is looking to leverage the information in PRIME and explore ways to report that information. For example, NJTPA staff, in an advisory capacity, used PRIME to prepare comments on some NJDOT Capital Program Selection Committee (CPSC) projects and have identified potential funding opportunities. Also, the NJTPA has used the application to respond to a request from NJ TRANSIT and the Federal Transit Administration to identify New Jersey locations that are potentially suitable for funding sources such as the Section 5311 Intercity Bus Program.

Mr. Vernick said it is hoped that the information in PRIME can be used earlier in the project planning process as projects are identified or scoped. He said he will be reaching out to RTAC members to identify more studies to be entered into the system and determine more ways PRIME can serve as a resource.

Ken Wedeen, Somerset County, asked if NJDOT should be required to include study recommendations from PRIME as part of their normal project development process for consideration by the CPSC. Jim Vari, NJDOT, said the agency already reaches out to county and local governments to incorporate or at least speak to ideas about any given project, sends CPSC agendas to counties and MPOs, and takes comments. He said PRIME can be a part of that going forward if that is the preferred vehicle for relaying comments to NJDOT.

V. Written Information Items

Ms. Goldman provided additional information concerning the long-range transportation plan update as a written item accompanying the agenda. She said staff is working on background papers, including one on asset management. She said the subregions have been very helpful reviewing bridge data and providing corrections and additions. She said Keith Miller, Central Staff, will send pavement data soon for their review. A variety of background papers will be released on a staggered schedule, beginning this fall.

- 4. Minor Amendment to the FY 2020 2023 Transportation Improvement Program to Add the Kearny Riverbank Park Bike Trail Project as Requested by the Town of Kearny
