## Meeting Minutes December 18, 2023

I. Roll Call of Members

Anne Strauss-Wieder, Central Staff, led the meeting on behalf of Commissioners Sarnoski and Sooy, who could not attend. She called the meeting to order at 1:00 p.m. There were 13 voting members of the Freight Initiatives Committee present.

II. Approval of Minutes

A motion to approve the minutes of the October 16, 2023 meeting was made by the City of Newark, seconded by Somerset County and carried unanimously.

#### III. Update on NJTPA Freight Division Activities

Ms. Strauss-Wieder said the high freight demand/supply "super cycle" is over, and the port activity is back to levels slightly higher than 2019. She said the region is seeing less demand for industrial space and more subleasing activity. She noted that there were only two new starts in the region during the third quarter, both less than 200,000 square feet. However, looking to the future, Ms. Strauss-Wieder said that there was a groundbreaking ceremony for the Port Street Corridor Improvements Project, a \$220 million initiative to enhance northern access to the port. Ms. Strauss-Wieder also discussed ongoing NJTPA projects, including the Freight Concept Development Program and the 2050 Freight Industry Level Forecasts Update.

#### IV. Presentations:

Janice Marino-Doyle, New Jersey Department of Transportation (NJDOT), provided an update on the federally mandated Statewide Freight Plan, which the Federal Highway Administration approved in 2023. The plan supports the growth of New Jersey's freight industry and the incorporation of new technologies and infrastructure into the system. The state must update its plan every four years. Ms. Doyle introduced project consultant, Stephen Chiaramonte, WSP, who outlined the plan's development and discussed next steps, noting that short-term actions include finalizing the designation of critical freight corridors, supporting data needs, and enhancing support for state freight funding sources. Longer-term actions include addressing statewide truck parking needs, increasing marine highway services, and preparing for extreme weather risks.

Next, Lou Millan, NJ TRANSIT, spoke about the federally mandated State Rail Plan, which articulates a vision, inventories the rail network, identifies needs, engages stakeholders, and sets the stage for grant funding applications. Alan Kearns, also of NJ TRANSIT, provided an overview of the plan's development, particularly the passenger side. The Plan is expected to be released this month for public review and submitted to the Federal Rail Administration in March. A brief Q&A session ensued.

V. Two-Minute Reports on Freight Activities from Committee Members

Ms. Marino-Doyle said NJDOT will hold Freight Advisory Committee meetings in March, June, and November. Also, the NJDOT Office of Multimodal Grants has received 18 applications totaling \$65.8 million for the Fiscal Year 2024 Rail Freight Assistance Program.

Stephan Pezdek, Port Authority of New York & New Jersey (PANYNJ), said that the sevenphase Port Street Corridor Improvement Project that Ms. Strauss-Wieder mentioned is scheduled for completion by mid-2028.

Ken Wedeen, Somerset County, said the 2045 Keep Somerset Moving Transportation Plan study is nearing completion and will yield several recommendations for freight and goods movement in the County.
