David Kooris	David Kooris is the Chair of the Board of the CT Port Authority. In that role since July 2019, Mr. Kooris has managed the public private partnership with Orsted and Eversource to jointly redevelop the state's pier facility in New London to support wind turbine staging. Leveraging wind to achieve multi-generational facility upgrades, the port will include two 5,000 lb/sf heavy lift pads supported by approximately 40 acres of upland area. The first pad and berth will be mobilized in the spring of 2023 to deliver South Fork and the second pad and berth will be the first host port of the Charybdis in early 2024, building Revolution and Sunrise Wind.
Julia Kortrey	Julia Kortrey is a Manager at NJEDA where she helps lead New Jersey's efforts on offshore wind workforce development, education, research, and innovation.
