> Meeting Minutes October 17, 2022

I. Roll Call of Members

Freight Initiatives Committee (FIC) Chair Commissioner Jason Sarnoski, called the meeting to order at 1:00 p.m. Jakub Rowinski, Central Staff, called the roll. There were 13 voting members present.

II. Approval of Minutes

A motion to approve the minutes of the August 15, 2022 meeting was made by Ocean County, seconded by Hudson County and carried with 12 affirmative votes. Warren County abstained.

III. Update on NJTPA Freight Division Activities

Mr. Rowinski said the NJTPA Freight Rail Grade Crossing Assessment Update, led by Cambridge Systematics, is expected to conclude by June 2023. The study will update an assessment completed by NJTPA in 2008 to address the impacts of freight rail traffic along the region's major freight rail lines. Mr. Rowinski reported also that two studies are being conducted under the Fiscal Year 2021 Freight Concept Development Program: the Berkshire Valley Road Truck Circulation Project in Roxbury, Morris County; and the Port Reading Secondary South Main Street Grade Crossing Elimination Project in Bound Brook, Somerset County. The studies are scheduled for completion in June 2023.

IV. Presentations: Strategies and Effective Practices for Planning for and Working with Developers on Industrial Development in Communities

Donna Rendeiro, Executive Director of the NJ Office of Planning Advocacy said planning and zoning boards around the state have been inundated with applications to build giant warehouses and distribution and fulfillment centers. She said that led the State to issue recent guidance to help municipalities determine how, or whether, to allow warehouses. The state's guidelines encourage a proactive rather than reactive approach, providing municipalities with factors to consider when updating their master plans and ordinances. The guidelines also support a regional approach to siting warehouses.

Wilda Diaz, former mayor of Perth Amboy in Middlesex County, said the creation of the Perth Amboy Redevelopment Agency in 1997 and the adoption of a redevelopment plan helped the city address a legacy of contamination at several former industrial brownfield sites. Ms. Diaz said one of the projects that came out of that plan is a Home Depot distribution center. The project invested \$500 million for new construction and more than \$10 million to remediate 92 acres of contaminated land, opening a logistics center that created more than 500 jobs. She said, through negotiation, the city was able to acquire open land and had a developer construct an amphitheater as well as major road repairs, infrastructure improvements, and other enhancements. Ms. Diaz said, overall, more than 500 acres of contaminated sites in Perth Amboy have been remediated, and this has attracted and generated nearly \$1 billion in new construction projects, nearly \$15 million in tax ratables, and more than 3,000 jobs for residents.

Commissioner Sarnoski pointed out that counties and municipalities do not have the tools that would require towns to work together and avoid a situation where one town reaps the benefits of industrial development, while adjacent towns must deal with the infrastructure issues of serving that development.

A wide-ranging Q&A session ensued.

V. Two-Minute Reports on Freight Activities from Committee Members

Stephen Chiaramonte from WSP for NJDOT said grant requests for the Rail Freight Assistance Program are under review, and the application period for grants under the Local Freight Impact Fund is open.

Stephan Pezdek, Port Authority of New York & New Jersey (PANYNJ) said, as of August, the Port has been named the nation's number one port, by volume, mostly due to a shift in incoming sailings to the East Coast rather than the West.

Alan Kearns, NJ TRANSIT, said the agency continues to develop the State Rail Plan, and expects to issue a draft early next year.
