

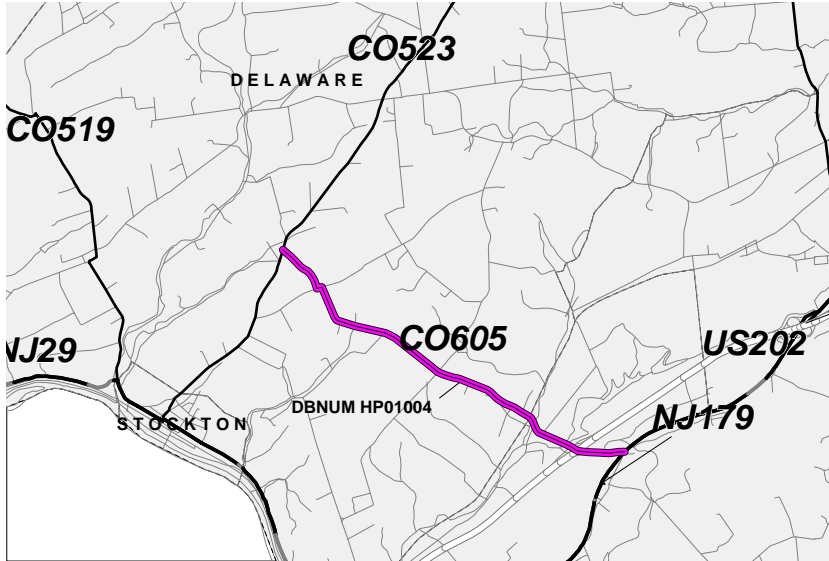

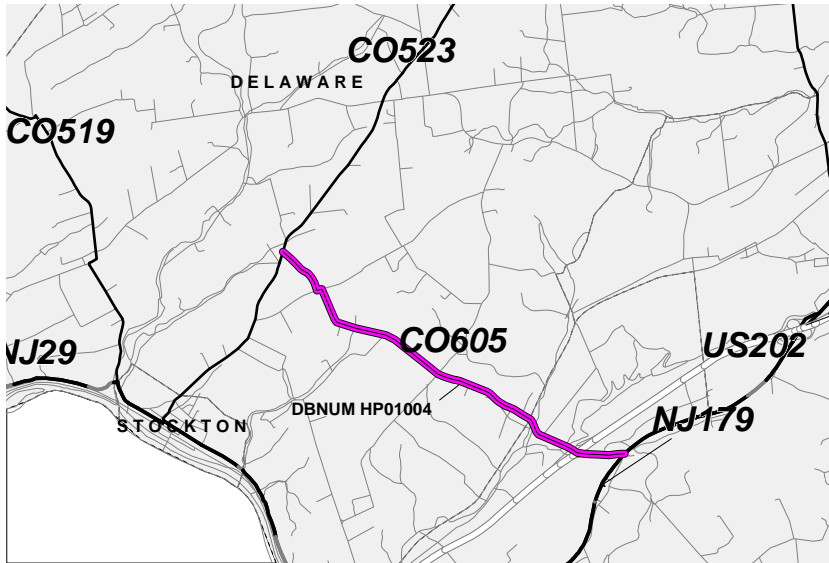

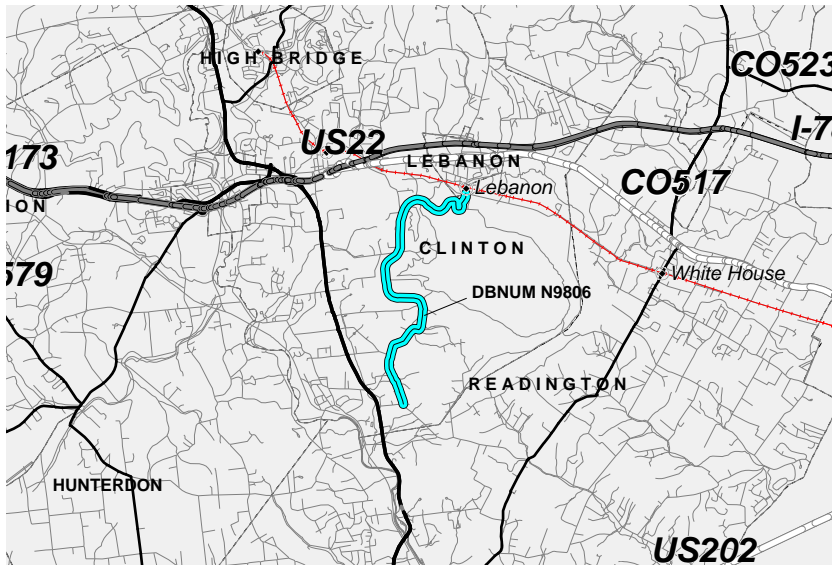

Large portions of the road run along the top of the dam and are protected on both sides with an old steel post and cable guide system. This project proposes to upgrade the guide rail and its end-terminals to current standards, install raised pavement markers, and upgrade regulatory and warning signs to Diamond Grade Reflective Material with breakaway posts.
